### **Directions:**

Eastbound on Route. 22: At traffic light at Walnut Hollow Shopping Plaza (Rite-Aid will be on left) make a left onto Cline Hollow Rd. Immediately, there will be a STOP sign. Go straight. After approximately 1.6 miles, at the STOP sign, turn left onto Hills Church Road. After approximately .3 mile, Hills Church Road becomes Wiestertown Road (stay straight). Continue approximately 1.4 miles, the entrance to MCP is on your left (just past Evans Road).

Westbound on Route. 22: At traffic light at Walnut Hollow Shopping Plaza (Rite-Aid will be on your right) make a right onto Cline Hollow Road. Follow directions above.

### **Entry Fee:**

**\$20 if registration form is postmarked by  
August 13<sup>th</sup>; \$25 after August 13<sup>th</sup>.**

T-shirts are guaranteed to those whose registration forms are received by August 13<sup>th</sup>; available while supplies last to those received after August 13<sup>th</sup> including day of race registration beginning @ 7:00 AM on Race Day (8/20/11).

### **Race Start:**

We will make every effort to have our competitive runners start the race at the front of the pack. This Event is scored by The Runner's High using the ChampionChip Timing System. On race day, all participants will be issued a rental computer chip which is attached to the shoe and worn throughout the race. Special mats at the finish line will record a finishing time for each chip. All rental chips must be returned at the finish line. There is a \$35 fee for each lost chip.

### **Awards & Prizes:**

Awards and prizes will be presented following the race on the main stage of Murrysville Community Day. Awards to Top Male & Top Female Overall and to 1st place in the following Male & Female age groups:

Runners: U10, 11-13, 14-16, 17-19, 20-29,  
30-39, 40-49, 50-59, 60-69, 70+

Walkers: No age bracket; awards to top 3.

Prizes will be given away by random drawing after awards are distributed. All registered participants are eligible for prizes. You must be present to win.
